VENDOR/BREEDER REGISTRATION AGREEMENT FORM  
A.E.B.C. AND LIVE OAK CIVIC CENTER - RULES AND REGULATIONS**

As evidenced by the signature on the Space Sign-up form page, the Vendor/Breeder hereby acknowledges and agrees to abide by the following rules and regulations:

**VENDOR SET-UP TIME:**

Day before set-up time is Friday from 1:00 p.m. to 8:00 p.m.

Day of the mart set-up time is Saturday from 7:00 am. to 9:00 a.m. (complimentary coffee and tacos for vendors:).

**SPACE:**

Each space includes one table (2-1/2 ft. x 8 ft.) and two chairs.

Space allotted for each area is predetermined and will not change with or without the table.

No more than two vendors can share a space.

All birds and merchandise must stay within your designated space area at all times.

**ELECTRICITY:**

\$25.00 WILL be charged for EVERY outlet you plug into, no matter how long you use it.

Use a multiple plug connector and only plug into the electrical outlet ONE time.

Two vendors CANNOT share the same outlet.

You are responsible for bringing your own extension cord and multiple plug connector.

Electricity is not available at every space area.

**ENTRANCES, FIRE EXIT DOORS AND AISLES:**

No birds or merchandise will be allowed to block the entrances, fire exit doors or aisles!

**LOADING & UNLOADING:**

Loading and unloading will be at the rear and sides of the building only.

No loading or unloading will be allowed through the front entrance doors.

No loading and unloading doors can be blocked open so people can go in and out during the Mart.

All vendors must move their vehicles after unloading and park either on the side or behind the Live Oak Civic Center.

**GENERAL INFORMATION:**

This mart site may be somewhat cool; be prepared to bring something appropriate for your birds and yourself.

No smoking will be allowed within the building.

No food or drink may be brought into the building.

No alcoholic beverages will be allowed within the building or on the Live Oak Civic Center grounds.

No video or regular cameras, or other recording equipment will be allowed within the building or on the grounds without prior approval by A.E.B.C.

Security guards will be in the building and on the grounds from 9:00 a.m. to 6:00 p.m. the day of the mart.

**CAGES:**

All cages, dishes, carriers, must be clean and have solid bottoms. If a cage is determined to be excessively dirty by the Mart Chairperson, the vendor will be requested to remove said cage.

**BIRDS:**

A baby bird feeding area will be provided (microwave, hot water, short term use of electrical outlets will be available).

To the best of the Vendor's/Breeder's knowledge his/her bird(s) are healthy and were obtained legally.

**A BIRD THAT APPEARS SICK OR OF QUESTIONABLE ORIGIN WILL BE REMOVED FROM BUILDING**

**ONLY VENDORS WITH SPACE WILL BE ALLOWED TO SELL OR BRING BIRDS INTO BUILDING OR ON THE LIVE OAK CIVIC CENTER GROUNDS. THIS IS FOR EVERYONE'S PROTECTION.**

**VENDOR/BREEDER:**

- All sales and guarantees are between the Buyer(s) and Seller(s); AEBC only provides the site for the exchange.
- **THE VENDOR/BREEDER MUST HAVE THEIR ORIGINAL TEXAS SALES AND USE TAX PERMIT ON DISPLAY IN THEIR SPACE.**
- The Vendor/Breeder is responsible for charging the appropriate Texas Sales and Use Tax (.0825 - 8.25%).
- The Vendor/Breeder is responsible for any and all costs incurred for treating or euthanizing sick, diseased or injured birds while attending the A.E.B.C. mart.
- The Vendor/Breeder is responsible for any and all costs incurred due to injury of patrons by himself or his/her bird(s).
- The Vendor/Breeder is responsible for any and all costs incurred due to damage of property by himself or his/her bird(s).
- The Vendor/Breeder is not allowed to post or attach any items on walls, ceiling, or doors of the Live Oak Civic Center.
- The Vendor/Breeder is responsible to clean up his area before leaving the building after the bird mart.
- The Vendor/Breeder **agrees** that this is a **CAGED BIRD (excludes poultry, dogs, cats, sugar gliders, etc., doves and button quail are accepted)** ONLY mart and they may not sell ANY other animal(s) in the building or on the Live Oak Civic Center grounds. ANYONE trying to do so will be asked to stop; if they do not, they will be asked to leave the building and grounds immediately! Any EXCEPTIONS must be pre-approved by the Bird Mart Chairperson!
- Objectionable behavior will not be tolerated by any adult or child whether it be a vendor or the general public. **ANYONE CAUSING A DISTURBANCE WILL BE ASKED TO LEAVE.**

**Alamo Exhibition Bird Club will not be responsible for any accident, injuries, or fatalities or loss of property.**
